

ORDINANCE NO: 2024-O-3

AN ORDINANCE ESTABLISHING 27-5-4(a) REMOVAL OF CONTENTS OF CONTAINERS/RECEPTACLES

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF HARTFORD, ILLINOIS, THAT:

WHEREAS, the Board of Trustees of the Village of Hartford, Illinois, has created an offense for removing contents from containers/receptacles that are for garbage and yard waste.

NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF HARTFORD that...

The Hartford Village Code Section 27-5-4 be added to create appropriate regulations/offenses for removing and/or adding contents to and/or from garbage containers/receptacles that are placed on their property.

Chapter 27, Article V, Section 4(a): REMOVAL OF CONTENTS OF CONTAINERS/RECEPTACLES:


It shall be unlawful for any person other than an individual employed or licensed by the Village of Hartford or the owner, occupant, tenant, or person in possession of the premises for which containers/receptacles for garbage and yard waste have been provided, to deposit any article or thing in such containers or to remove, displace, injure, deface, destroy, uncover or disturb such container or any portion of its contents.
